Thanks to the unwavering support of our partners and communities, we catapulted our flagship Cascades of Learning initiative from 14 to 214 government schools in Bihar, and from 10 to 50 schools in Madhya Pradesh, India. In both cases, local governments in India, impressed by our results, invited us to collaborate on district-wide implementation to scale up to unprecedented levels. Additionally, in our Organic Kitchen Gardens program in Maharashtra, India we went from supporting 3,000 women to 5,000 women in growing their own gardens and being able to supply food for themselves and their family.
